

## Ontario Visiting Graduate Student (OVGS) Application July 2022

## **Ontario Visiting Graduate Student Plan General Information**

The plan allows a graduate student registered graduate course (audit not allowed) at a university in Ontario (Home University) to take a graduate course at another Ontario University (Host University) without completing further admission formalities. The student pays fees to McMaster University and is classified as a visiting student at the Host University, where they pay no fees.

## **Responsibilities of the Student**

The student must complete the **Ontario Visiting Graduate Student Application**, ensuring that all requested information is clearly indicated. Student must then obtain approval for the course(s) requested in the sequence specified on the form.

It is the student's responsibility to ensure that the application reaches the Host University Graduate Office as early as possible, and not later than the final date for registration of the term in which course(s) concerned are to be taken.

In the event of the withdrawal from a course, the student must send a Notification of Withdrawal from Course(s) to the Graduate Offices of McMaster University and of the Host University. The last date for withdrawal is the date specified for this purpose by the Host University. Failure to respect this deadline may result in the recording of a failing grade on the student's record.

Refunds, if any, are governed by the appropriate policies of McMaster University.

The student must arrange to have an official transcript with final grade sent to McMaster University as soon as the final results of the course(s) are available.
