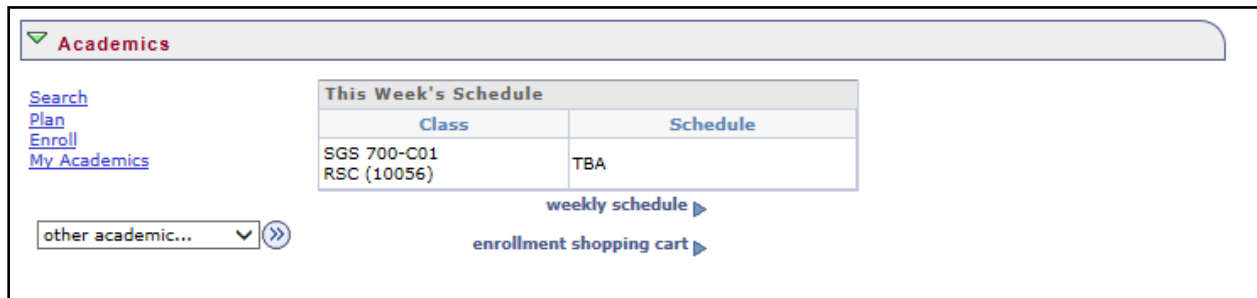

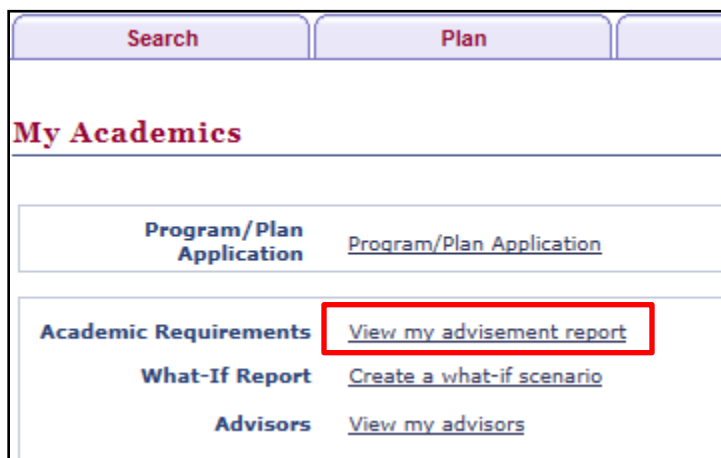
### Accessing your Academic Advisement Report:
